## **December Zoning News**

### Planning Commission Meeting - December 3 at 7:00 pm

**The JCCA strongly opposes proposed Zoning Text Amendment A-19-003** City Staff is recommending a Zoning Text Amendment (A-19-003) to delete the reinitiation requirement language and extend the waiting period for denied land use petitions. Currently land owners with denied petitions must wait 12 months and must demonstrate that their land use petition is significantly different from the previously denied petition before re-initiation is considered. Staff recommends removing the " significant difference" language and changing the waiting period to 18 months. We are very concerned that removing the re-initiation requirement will allow previously denied petitions to come back up again and again (with only very minor changes) until residents develop fatigue and stop voicing their opinions. Change will be discussed at Planning Commission meeting on December 3 at 7:00 pm. City Council will vote on Monday, December 9. Zoning Text Amendment - Section 28.2
