Medlock Bridge to host Post 4 Candidate Debate Tuesday, October 22, 7:00pm to 8:30pm

Candidates Adam Thomas, Chris Coughlin (Incumbent), Kent Altom, and Marybeth Cooper



Format will be 10 minutes candidate introduction, outlook for the future of John Creek, and view on four popular questions:

- 1. What is your position on changing SR 141 to 6 lanes?
- 2. What is your position on the 5 proposed options for State Bridge / 141 intersection?
- 3. What is your position on storm water management, particularly with regard to neighborhood retention/detention ponds
- 4. The City Charter states the Mayor and City Council members cannot have discussions of vote count discovery how each may vote on a specific item on the upcoming agenda for the Work Session or City Council Meeting. Do you think if you are elected you can follow the charter on this subject?

After the 40 minute introduction session, there will be an hour of Q&A. A moderator will pose the same question to each candidate who will have up to 2 minutes to respond. ## **Zoning Ordinance Text Amendment Change**

City Staff is recommending a Zoning Text Amendment (A-19-003) to delete the re-initiation requirement language and extend the waiting period for denied land use petitions. Currently land owners with denied petitions must wait 12 months and must demonstrate that their land use petition is significantly different from the previously denied petition before re-initiation is considered. Staff recommends removing the "significant difference" language and changing the waiting period to 18 months. City Council will discuss at the October 21 Work Session.
